Glossary

Interim moratorium period - Period during which a local community interest group can request to be treated as a potential bidder

Full moratorium period - Period during which the asset owner can only dispose of the property to a community interest group that has requested to be treated as a potential bidder during the interim moratorium period

Listing review - A review by the local authority at the request of the owner of their decision to list a building or other land as an Asset of Community Value

Current appeals - The opportunity for an owner to appeal at independent tribunal against the Local Authority's decision to list an Asset of Community Value

Protected Period - Period during which the asset owner can dispose of the asset on the open market either because no agreement has been reached with a local community interest group or there were no requests from potential bidders during the interim moratorium period

Notice of Disposal - Notice to the Local Authority (under Section 95(2) of the Localism Act) of the owner's intention to dispose of an Asset of Community Value

Expiration - The 5 year date from the successful nomination on which the asset must be renominated an Asset of Community Value
